WHO WE SERVE

Our service area includes the City of Aurora and Arapahoe County. Most of our clients are women and a third of those we serve are dependent children, with men, LGBTQIA folks and all victims welcomed. Most clients are low-income, earning at or below 30% of area median income.



THE OPPORTUNITY

Under the direction of Extended Stay Shelter Director, the Case Manager provides services to victims of domestic violence that include crisis intervention, individual emotional support, advocacy and assist with gaining access to housing. Our Advocates are adept at handling crisis situations and working with diverse populations.

This position can be a full-time position working from 12 PM – 8 PM Monday through Friday at our Extended Stay Shelter located in Englewood, CO. There may be flexibility to work daytime shifts on Tuesday and Thursdays. This role can also be filled with a Monday through Friday working 4 PM – 9 PM as a part time position. The hiring pay rate of \$20.75 – \$21.75 per hour.

As a part-time employee, you are entitled to vacation, sick leave and Gateway recognized holidays on a pro rata basis.

WHAT YOU WILL BE DOING

- Crisis intervention, screening, and assessment services to victims of domestic violence, including intake into our residential services.
- Provides advocacy support as needed; may serve as a liaison between local agencies and clients on an emergency basis.
- Assists with applying for benefits and securing necessary documentation.
- Maintains complete client files, including standard forms and progress notes.
- Interacts with clients and resolves disputes using mediation skills.
- Responsible for proper safety precautions and security procedures.
- Understands trauma informed care and how to use it in crisis situations.
- Develops awareness of community resources available to referral partners.

WHAT YOU WILL BRING TO OUR ORGANIZATION

- Bachelor's degree in human services, Social Work, or related field preferred, but related work experience will be considered.
- A minimum of one year's experience in human services with experience in case management and crisis intervention, including a working knowledge of domestic violence dynamics.
